

Recreation Industry Council of NSW in the state
of New South Wales and Outdoors ACT in the
Australian Capital Territory as a not for profit (for
purpose) association that trades as Outdoors NSW
& ACT. By the end of the year we were registered as
a Company Limited by Guarantee as Outdoors NSW
& ACT Limited.



We do this by leading and strengthening the outdoor sector to meet population needs now and into the future and promote sustainable growth for the environment and the organisations we work with.

Outdoors NSW & ACT has been evolving for over 38 years.

Established in 1984 as The Outdoor Professionals and later becoming the Outdoor Recreation Industry Council of NSW (ORIC) and now Outdoors NSW & ACT, the organisation has long been recognised as the peak industry body representing the interests of outdoor practitioners and employers in New South Wales and in 2019 extending its network to support those in the Australian Capital Territory.

The organisation has benefited from thousands of hours of volunteer time by board of directors, subcommittees and stakeholders to advance the benefits that outdoor recreation, education, therapy and adventure tourism provide.

## **Newly appointed Director**


Dr Phil Harmdorf

Ky won a Taurus Award – the Oscars of the stunt industry - in 2012 for Best Female Stunt Performer in the world. She has doubled for other stars such as Jennifer Garner, Anne Hathaway, and Jaime Alexander. She has co-hosted, produced and participated in some of the most extreme TV survival shows ever made. For the woman who grew up in the middle of nowhere in South Australia, it was a long way to the top.

Ky supports the Outdoors NSW & ACT programs through her role as Ambassador and you never know where or when she might pop up to meet more of the industry and participants of the outdoor adventurous activities to help spread the word of her own learnings in the Outdoors.



# Section 2 - Our Finances



## **Treasurer's Report**

Associations are exceptionally vulnerable at times in crisis as businesses watch their expenses and carefully watch where every dollar goes. The last 2 years have shown this to be the case and associations would normally experience a downturn in membership during such times and need to diversify funding to keep their activities going. I am pleased to report that the services we provide as membership benefits seem to have bucked this trend, and in the last year we have seen membership grow by 27%. A fabulous result to ensure we gain more of the industry voice for better outcomes across the larger industry. We acknowledge however that we still have a long way to go to get the majority of the industry into the network and we will continue to do strive for a better representation of the whole industry.

Why I mention the membership situation is because this is the base which provides the resources to achieve our objectives. Without the staff there would be no membership benefits or opportunities that continually strive for a better return for the industry.

However this did not stop our diversification strategy when it came to our finances. We have worked hard to attract project funding through grant opportunities, and funding partnerships which support development and growth of the industry.

The financial challenges of 2021–2022 will continue into the new financial year due to our commitment to the National Outdoor Education Conference that we are hosting in NSW for Outdoor Education Australia. This event was scheduled for 2020, then 2021 and now 2022. As a result this event started the financial year with a negative balance sheet. Through the incredible work of our team we are forecasting a cost neutral event and an event that can be celebrated because of the resilience of the industry and determination of the attendees

to commit, no matter what year it was to be held. We sincerely thank those who have had faith and stood behind us in this turbulent time. See you in September 2022!

As a true not-for-proft it needs to be stated that while the financial results look like a large financial return as profit, indeed these funds are fully committed to projects that will be expended in the 2022-2023 year, such as the National Outdoor Education Conference and grant funded projects.





## **Active Outdoor Kids Report**

The Youth Resilience Program funding was awarded to ONSWACT in May 2021 through the Bushfire Community Recovery and Resilience Fund (BCRRF), which is a joint Commonwealth - State Disaster Recovery Funding Arrangement.

We have re-branded it to the Active Outdoor Kids (AOK) Program, which provides active recreation opportunities for 7-17 year olds to promote community wellbeing and future disaster resilience following the 2019 bushfires. The program has begun to take place in 12 bushfire affected communities across the Greater Sydney, North Coast, and Hunter regions. Each program offers four weeks of afterschool activities plus a three-day school holiday camp. This is offered free of charge to students thanks to the grant received.

Despite many setbacks due to COVID lockdowns and floods, the structure of the program is in place and has been tested during pilot program operations. Detailed program structure and planning has been required to ensure safe delivery of the program by external operators, as well as efficient use of the allocated funds. ONSWACT has commenced and completed the following to date:

- Program has commencement in two pilot locations. Portland and Port Macauarie
- 70 young people have completed the after-school program
- 60 young people from Port Macquarie are registered to go on a 3-day camp 1-3 July 2022
- Portland camp is scheduled for 12-14th September
- Lake Macquarie and Blue Mountains programs are scheduled to commence in Term 3
- We are negotiating for the commencement of the program in four locations for later in Term 3 or early Term 4, 2022.

 ONSWACT is on track to complete after-school activities and camps in all other locations by the deadline of the funding agreement on 30th June

ONSWACT has also been seeking Local, State and Federal Government grants to continue the AOK program, or expand service into other locations.

We wish to thank the support of the Youth Resilience Committee for their guidance with this program.



## 2021/2022 Activity Summary

ONSWACT provides activity across 4 pillars; Advocacy, Education, Connection & Promotion. Here is a quick snapshot of our activity this year.

- · Worked with the Office of the Board of Senior Secondary Studies ACT on the new Outdoor Curriculum
- Continuous advocacy for access for Outdoor activities, such as Slacklining, Highlining, Trail Bike Riding, Rock Climbing
